**Kapiti Bearings and Locksmithing Tournament:** I would like to acknowledge the generous sponsorship by Kapiti Bearings and Locksmithing towards our recent successful in-house tournament. Also I would like to thank Dennis Lahman for donating his time in directing this tournament and thank all the other people who gave their time to make this tournament the success it was.

**Noise:** It has been noticed that at some sessions it can get quite noisy, especially at start of play when the Director is trying to do announcements, and when some tables complete their boards, making it hard for those still playing to concentrate on their hands. Please respect your fellow players and all Director instructions as keeping noise down can only be achieved with your cooperation.

**Trophies:** In the first newsletter for this year you were asked to contribute your feedback on a suggestion about changing the way trophies were presented, due to over two thirds of the trophies not being taken home and the wear and tear some trophies are showing.

The committee has considered various options and have decided that the trophies will now be kept in the trophy cabinet and certificates will be awarded to the competition winners, the week after the competition ends. All competitions will retain their current names and these certificates will reflect this. The competition winners will continue to be recorded in the 'Honours Book'.

**Dealing Machine:** The dealing machine is currently away being repaired. Thanks to Trevor Smith and his team of dealers who have dealt an extra week's hands to enable us to send the machine away for repair. Our machine is now at least seven years old; the suppliers of our machine have advised us that it will not be supported after mid-2015 and there is a very limited supply of spare parts. Bearing this in mind the committee has decided that we should purchase a new dealing machine. As the new machine will cost us \$7,615.00 the committee has lodged an application with Pub Charity Limited for a grant towards the cost of the new machine. This new machine has many improved features and advantages over the current machine. These features should make the dealers' lives a lot easier.
